Happenings 2019 - 2020

Dear members,

The last fiscal year (July 1, 2019 – June 30, 2020) started with a very successful biennial global conference in Lima, Peru, with more than 500 participants. The impressive archaeological settings, the delicious food, and the well-organized conference resulted in a memorable conference. Thank you Deborah Delgado and Juan-Camilo Cardenas, the co-chairs of IASC 2019!

During the Lima conference, the process of establishing an Early Career Network of the IASC began, moderated by Beril Ocakli. The ECN provides opportunities for career development and networking and is becoming an essential component of the IASC. As of the date of this report, their membership has grown to 28 engaged and highly motivated members.

In October 2019, Charlie Schweik organized the second <u>World</u> <u>Commons Week</u> October 6-12 with more than 50 events worldwide.

IASC council member Esther Mwangi passed away too early on October 5, 2019. The IASC, in collaboration with the Center for International Forestry Research and Esther's family, established the <u>Esther Mwangi Memorial Scholarship Fund</u> to support African commons scholars in her memory.

In March 2020, we held the third annual Arizona IASC workshop during the week when the world flipped to a lockdown due to the COVID-19 pandemic. This was the last in-person event we could organize until further notice.



Highlights 2019 - 2020

In April 2020, we started bi-weekly webinars as reflections on resilience and the commons revealed by COVID-19 in collaboration with the Resilience Alliance and the Center for Behavior, Institutions and the Environment at Arizona State University to provide a platform of discussion during the pandemic. We have preserved these webinars on the <u>IASC Youtube channel</u> where they continue to get views.

In June, we held our first Virtual Summer School on Institutional Frameworks with 21 participants from all over the world. This successful summer school, which was planned to be virtual before the pandemic, demonstrated the opportunities that new technologies like Zoom provide to implement affordable international advanced education on the commons.

The IASC secretariat moved to Arizona State University where Caren Burgermeister formally took over the Executive Directorship in January 2020 from Rene van Weeren, after the transition year 2019. In the transition year, we spend quite some effort to reorganize the secretariat's activities with a new look and structure of the website, a more user-friendly membership database system, and more regular news updates to members.

Since a key function of the IASC is to facilitate the organization of events by and for members, the ongoing COVID-19 pandemic is causing organizational and financial challenges. For the foreseeable future we will continue to hold virtual events. Stay tuned for IASC 2021!


